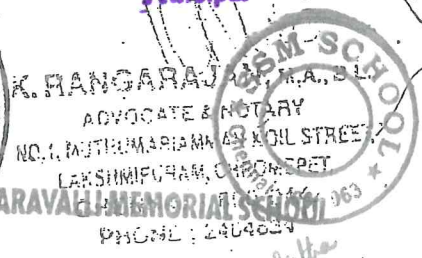
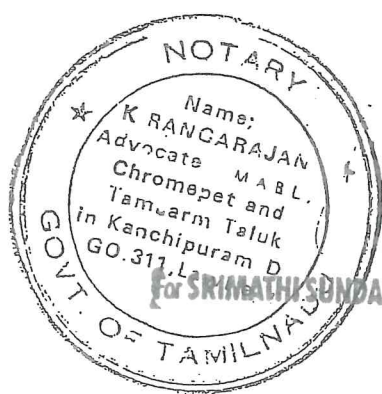
NOW THEREFORE THIS INDENTURE OF TRUST WITNESSES AS FOLLOWS:

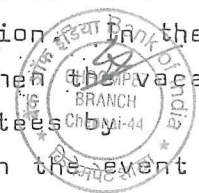
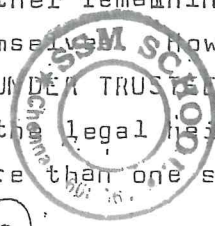
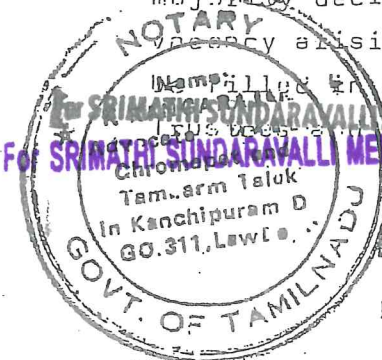
Term of Office of the Trustees:

The Founder Trustees shall each hold office for his life time or until he resigns. The terms of office of all other Trustees shall be three years from the date of their appointment.

Vacancies:

Vacancies occurring in the Office of TRUSTEE shall be filled by the Founder Trustees by majority opinion. In the event of the Founders ceasing to be Trustees, then the vacancies shall be filled by all the other remaining Trustees by majority decisions among themselves. However in the event of a vacancy arising among the FOUNDER TRUSTEES, the vacancy will be filled only by any of the legal heirs of the Founder more than one such legal heirs, then

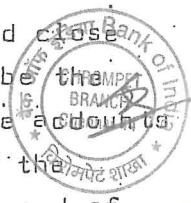
Vacancy not to invalidate: Any vacancy in the Board of Trustees or any irregularity in the appointment of the Trustees or their proceedings shall not invalidate any prior act or decision of the Board of Trustees.

Managing Trustee:

One of the Founder Trustee K. Santhanam shall be the Managing Trustee of this Trust. He shall hold office as such for life or until he resigns. When he ceases to be the Managing Trustee, the post of Managing Trustee shall be filled by the eldest among the other Founder Trustees and subsequently also as the Managing Trustee's post falling vacant shall be filled by the eldest among the other Founder Trustees.

Power of Managing Trustees:

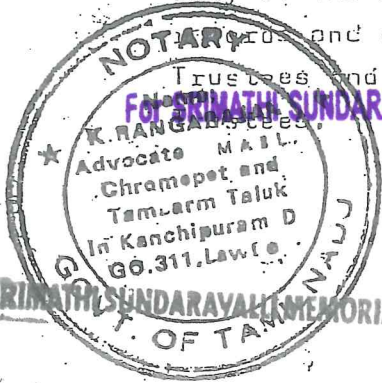
Subject to the control and directions of the Board of Trustees, the Managing Trustee shall have the general conduct of the affairs and management of the Trust and its properties and business with power in particular to enter into various contracts on behalf of the Trust. Delegations of Powers and Duties of a Trustee:

The Trustee may from time to time delegate to the Managing Trustee or more of their body such of their powers and duties as they deem fit, subject nevertheless to retaining their ultimate control and supervision. The Properties and funds of this Trust including the corpus and income shall be applied for furthering the objects of this Trust.

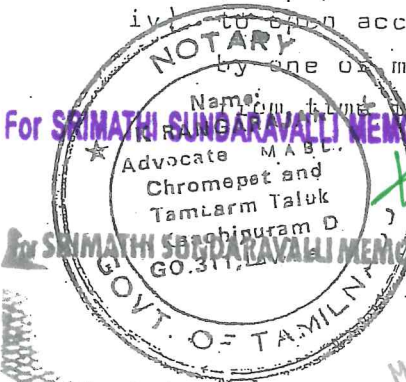
Power of the Trustees:

The Trustees shall have full power and authority to administer the Trust, its properties, business and funds and to do all such acts deeds and things as are calculated to fulfil the objects for which this trust is created. They shall be entitled to act not withstanding any vacancy in the Board of Trustees subject however to the clause herein contained regarding the decisions of the Trustees. Even if the number of Trustees be less than the minimum three they may nevertheless act for the purpose of filling up the vacancies on the Board of Trustees.

The Trustees shall have the following powers for the purpose of the Trust:-

- i) to acquire by purchase, grant, gift, exchange, lease, hire or otherwise, lands, buildings, stocks, shares, securities, movable and properties of every descriptions.
- ii) to sell, mortgage, grant in lease hire and otherwise alienated all properties of the Trust.
- iii) to borrow money with or without security and repay same.
- iv) to open accounts in banks and private for their operations

- v) to enter into all contracts on behalf of the Trust and receive them.
- vi) To invest the funds of the Trust not immediately required for the purposes of the Trust in such manner as they deem fit and to vary all such investments, without being subjects to the limitations of Section 20 of the Indian Trust Act, Income-Tax Laws or any other law governing the Trust.
- vii) To receive, collect and enforce recovery of all monies due or payable to the Trust and grant necessary receipts and discharges therefor.

- xi) to incur all necessary expenses in connection with the Trust and its Management.

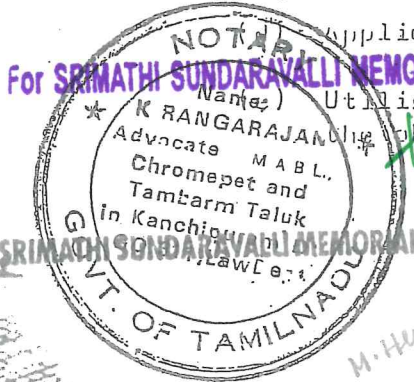
Decisions of the Trustees:
